

## Information from the Central Register of Wills

In accordance with Section 78f (1a) of the Federal Code for Notaries (Bundesnotarordnung, BNotO) or Section 66 (5) of the Regulation (EU) N° 650/2012 of the European Parliament and of the Council of 4 July 2012 on jurisdiction, applicable law, recognition and enforcement of decisions and acceptance and enforcement of authentic instruments in matters of succession and on the creation of a European Certificate of Succession (EU Succession Regulation), the Central Register of Wills will provide information upon request to the following competent authorities:

- 1. Foreign courts within the meaning of Article 3 (2) of Regulation (EU) No. 650/2012 and foreign authorities responsible for issuing the European Certificate of Succession, information on custody information from the Central Register of Wills and
- 2. Notaries established in another Member State of the European Union with the exception of Denmark and Ireland.

The information will only be provided in a matter concerning the succession and if it is necessary for the fulfillment of the tasks of the courts and notaries. During the lifetime of the testator, the information can only be obtained with his or her consent.
